A Democratic Presidential Preference Primary will be held on Saturday, February 29, 2020. This primary will be conducted in the polling places listed in this notice.

The deadline to register and be eligible to vote in the Democratic Presidential Preference Primary is January 30, 2020.

The polling place locations for some precincts may be combined with others for the primaries, as allowed by law. The polls will be open from 7:00 a.m. until 7:00 p.m. at the polling places designated below. These primaries will be held under the rules for providing Photo ID at the polling place. Voters will be asked to provide one of the following Photo IDs at their polling place.

- S.C. Driver's License
- ID Card issued by S.C. Department of Motor Vehicles
- S.C. Voter Registration Card with Photo
- Federal Military ID
- U.S. Passport

If you have one of these IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration and elections office. Voters who encounter reasonable impediment to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their reasonable impediment to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county election board has grounds to believe the affidavit is false. At 9:00 a.m. on Saturday, February 29, the county board will begin its examination of the absentee ballot return envelopes from the Democratic Presidential Preference Primary at the Berkeley County Voter Registration and Elections Office, located at 6 Belt Drive, Moncks Corner, SC 29461. On Thursday, March 5, at 10:00 AM the County Board of Canvassers will hold a hearing to determine the validity of all provisional ballots cast in the Democratic Preference Primary. This hearing will be held at the Berkeley County Voter Registration and Elections Office, located at 6 Belt Drive, Moncks Corner, SC 29461. (843)-719-4056.
