**CITY OF GOOSE CREEK**

**GENERAL ELECTION 2020**

The Berkeley County Elections & Registration Board announces the General Election for the City of Goose Creek to be Tuesday the 3rd day of November 2020.

The following offices shall be included in this election:

Three (3) Town Council Seats

Any person wishing to file as a candidate for the above listed offices may do so by bringing the filing fee of \$150.00 (one hundred fifty) for Council to the Berkeley County Elections office. This office is located at 6 Belt Drive, Moncks Corner, SC 29461. Books will be open for filing August 3, 2020 at noon and will remain open during regular business hours until August 17, 2020 at NOON.

The dates of filing are **August 3 – August 17, 2020**.

Council seats are for a four (4) year term, expiring November 2024.

People desiring to vote in the upcoming election must be registered by October 3, 2020. To register, one must contact the County Board of Voter Registration & Elections.

Registered electors who cannot vote in person may be eligible to vote by absentee ballot. Voters wishing for more information concerning absentee voting should contact The Berkeley County Elections & Registration Office.

This is a nonpartisan election and no party affiliation shall be placed on the ballot.

The polls shall open at 7:00 AM on Election Day and close at 7:00 PM.

At 9:00 AM on the day preceding Election Day the County Board of Elections & Registration shall begin the process of examining the absentee ballots. This examination will be held at the County Elections Office, 6 Belt Drive, Moncks Corner.

On Friday, the 6th of November at 10:00 AM the County Elections & Registration Board will hold a hearing to determine the validity of ballots challenged in this election.
