## APPLICATION FOR FAMILY DAYCARE HOME

**A “Family Daycare Home”** is defined as *an occupied residence in which child day care is provided no more than two days a week for periods of less than 24 hours, but more than four hours, for no more than six children, including those children living in the home and children received for day care who are related to the resident caregiver. Family day care homes are licensed by the South Carolina Department of Social Services (DSS).* **Any Family Daycare Homes that comply with the zoning regulations shall be allowed as an accessory use to any allowed residential principal use.**
